

**Pilgrimage for Restoration 2024**

written directions – walking, all three days

**Day One** Friday, September 27 19.1 miles Warren Co. - Saratoga Co.

1. From the assembly area at the Lake of the Blessed Sacrament, in sight of the monument of St. Isaac Jogues, in the Battlefield Park: proceed southeast across meadow, uphill to Fort George Rd; turn right (south) onto Fort George Rd; go 0.4 mi. to US Rt 9 **Police escort!**
2. bear slight right (zig) across Rt 9 and bear slight left (zag) onto Prospect Mtn Hwy; go 0.8 mi. into Autopark, to trail head – approx. 1,000 ft beyond toll gate
3. turn left (south) through boulders, onto snowmobile trail into woods, following CSRG Routes leaders: Go approx. 200 yards [note trail sign “To Lake Luzerne”] and turn left marked by second yellow/black snowmobile sign; follow trail approx. 4,500 ft keeping, baseball fields & then ‘dog park’ on right; follow trail downhill at dumpsters & white shed, into thick woods; cross brook over wooden footbridge at four-way intersection - staying straight following “Corridor 4B” and “Lake Luzerne 10.5 mi.” signs, then uphill keeping close parallel to Transfer Rd, on the right; then loop left, away from Transfer Rd, following yellow sign “Bridge Ahead”: look for mini red stop sign and “Quiet Please – residential area”: bear hard right in direction of back yard of residence with tall wooden fence – skirting right, around fence, approx. 100 ft to intersection of Transfer Rd and Rt 9N [Distances are approximate.] [ total distance on trail = approx. 0.9 mi. time = 18 mins ]
4. exiting trail/woods, cross NY Rt 9N **in echelon**, turning right onto Rt 9N **Police escort!**  
**PENDING ON SITE CONFIRMATION of road suitability, follow turns 4.1. – 4.4. below to detour off Rt 9N for safety, as follows –**
  - 4.1. At 0.7 miles from Transfer Rd turn slight left onto Old State Rd, go 0.4 mi. to Rt 9N
  - 4.2. turn slight left onto 9N, go 1.8 mi. to Gage Hill Rd
  - 4.3. turn left onto Gage Hill Rd, go 1.1 mi. to Rt 9N
  - 4.4. cross Rt 9N directly to rest stop at **Ciro's Restaurant** **If no confirmation of detour, stay on Rt 9N to Giro's.**
5. follow Rt 9N (west) 3.8 miles to **Ciro's Restaurant**, where column halts to rest  
[ interval 1. - 5. distance = approx. 6 miles time = 2 hrs ]
6. continue on Rt 9N, go 0.7 mi. to Northwoods Rd (at Urban Cowboy Saloon)
7. turn left (south) onto Northwoods Rd, following sign for “Painted Pony Ranch”, go approx. 50 yards
8. turn right (southwest) onto Howe Rd, go 2.8 miles to “Y” intersection with Towner Rd
9. bear left to stay on Howe Rd (south-southeast), go 0.9 mi.
10. turn right (southwest) onto Read Park Rd, go 0.6 mi. to Rt 9N (at Holy Infancy Church)
11. turn left (south) onto Rt 9N: go 0.4 mi. to Mill St, where column halts for lunch at Mill Park  
[ interval 6. - 11. distance = approx. 5.5 miles time = approx. 1 hr 50 mins ]
12. exiting Mill Park, turn left on Rt 9N, go 0.2 mi.
13. turn – soft - right (south-southwest) onto Traver Rd – at School St – go 0.2 mi. on Traver
14. turn left (southeast) onto Bay Rd – unmarked, at Hudson River, go 0.2 mi.
15. cross 9N at traffic light, staying straight: Bay Rd becomes East River Dr, go 5.0 miles
16. cross The Hudson, **into Saratoga County**; walking column turns right to circle under bridge & follow macadam footpath, go 0.3 mi. to Curtis Park [NOTE: DRIVERS turn left onto River St, then left at next “T”]
17. pause at Curtis Park to rest [ interval 12. - 17. distance = approx. 6 miles time = approx. 2 hrs ]
18. exit Park, heading left onto River St: go 0.2 mi. [ Detour for construction possible; pending further instructions en route. ]
19. turn right (west-northwest) onto Palmer Ave, go 0.2 mi. [ Police escort may be needed. ]
20. turn left (south) onto Main St, go 1.0 mi.
21. [ vehicles turn right (southwest) onto Stark Rd [street name on sign is faded], drive 0.1 mi. to driveway ]
22. column walks directly onto campus green - Full Gospel Assembly, 20 Stark Rd, Corinth 12822  
[ interval 18. - 22. distance = approx. 1.6 miles time = approx. 32 mins ] Pastor Victor Muravski 518-654-6992

**Day Two** Saturday, September 28 21.7 miles Saratoga Co.

1. Departing the bivouac, turn right (south) onto Stark Rd, go 0.3 mi.
2. turn left (south-southeast) onto Angel Rd – unmarked, go 2.9 miles to Spier Falls Rd – unmarked
3. turn right (west-southwest) onto Spier Falls Rd, go 2.4 miles to flashing red traffic light at NY Rt 9N
4. turn left (south) onto Rt 9N, go 0.1 mi. to driveway leading into Mrs. Decoteau's property
5. turn right into driveway (unmarked) at 4104 Rt 9N, Greenfield Center NY 12833; halt to rest  
[ interval 1. - 5. distance = approx. 5.8 miles time = approx. 1 hr 56 mins ]
6. exit Mrs. Decoteau's property: turn left (north) onto Rt 9N, go 0.1 mi. to flashing yellow traffic light
7. turn left (west) at flashing light onto North Greenfield Rd – no street sign, go 1.7 mi. to intersection with Allen Rd (north) & Porter Corners Rd (south): where N Greenfield Rd becomes North Creek Rd
8. continue straight (WSW) on N Creek Rd, go 3.4 miles to Sand Hill Rd [ **Heads-up!** New route to new camp. ]
9. turn right (north-northwest) onto Sand Hill Rd, go 0.2 mi.; halt for lunch on grassy roadside  
[ interval 6. - 9. distance = ca. 5.4 mi. time = ca. 1 hr 48 mins ]
10. continue on Sand Hill Rd., go approx. 500 feet to Daketown Rd
11. turn left onto Daketown Rd, go 1.2 mi. [ ATTENTION! Same road changes names hereafter twice.]
12. crossing Lake Desolation Rd, stay straight: Daketown Rd becomes Kilmer Rd, go 0.4 mi.; Kilmer Rd becomes Boyhaven Rd, go 1.2. mi. to Young Rd
13. turn right (west) onto Young Rd, go 1.1 mi. (to Hughes Rd)
14. bear left to *stay on Young Rd* (at fork with Hughes Rd), go 0.4 mi. to Fishback Rd
15. turn right onto Fishback Rd, go 0.9 mi. to Antioch Rd [ interval 10. - 15. approx. 5.3 mi. ca. 1 hr 46 mins ]
16. turn left (south) onto Antioch Rd, go 0.5 mi. to NY Rt 29 W CAUTION, narrow – highway! **Police escort!**
17. turn right (west) onto NY Rt 29, go 0.2 mi. to Jockey St
18. turn left (south) onto Jockey St/Co. Rt 52, go 0.2 mi. to Welch Rd
19. turn left onto Welch Rd, go 0.1 mi. to grassy roadside across from East Galway Cemetery; **halt for rest**
20. continue on Welch Rd, go 0.2 mi. to Shaw Rd

21. turn right onto Shaw Rd, go 0.3 to Jockey St
22. turn left onto Jockey St, go 0.5 mi. to Hermance Rd
23. turn right onto Hermance Rd, go 1.2 mi. to Parkis Mills Rd
24. turn left onto Parkis Mills Rd, go 0.8 mi. to Alexander Rd
25. turn right onto Alexander Rd, go 1.2 mi. to Camp Woodhaven 2015 Alexander Rd, Galway 12074  
GSA NE NY rep 518-489-8110 [ interval 16. - 25. distance = 5.2 miles time = 1 hr 24 mins ]

**Day Three** Sunday, September 29 20.5 miles Saratoga, Fulton, Montgomery Counties

1. Exiting Camp Woodhaven turn right (west) onto Alexander Rd, go 0.1 mi. to NY Rt 147/Sacandaga Rd
2. turn right (north) onto Rt 147, go 0.9 mi. to Hermance Rd
3. turn left (west) onto Hermance Rd, go 0.7 – to fork-intersection with Greens Corner Rd
4. turn left to stay on Hermance Rd, go 1.0 mi. – to fork-intersection with Ridge Rd
5. bear right/straight onto Ridge Rd, go 0.3 mi. to DANGEROUS intersection at Crooked Rd **DANGER!**  
Cross over Crooked Rd with CAUTION, safeties, and **police escort!**
6. stay straight on Ridge Rd 3.1 miles to Honeywell Corners Rd – Note: 2024 route re-meets route of 2023 here.
7. stay straight on Ridge Rd 0.9 mi. to halt for rest in fields on right – Note: rest is 0.3 mi. short of Hagaman Rd.  
[ interval 1. - 7. distance = approx. 7.1 miles time = approx. 2 hrs 22 mins ] **Police escort!**
8. continue 0.3 mi. to Hagaman Rd; turn left (south) onto Hagaman Rd/Co. Rt 126, go 0.6 mi.
9. turn right (west) at 4-way blinking light onto Fulton Co. Rt 107, go approx. 3.8 miles to Noonan Rd
10. turn left (south) onto Noonan Rd, go 3.0 miles [ Enter **Montgomery Co.** 1.2 mi. south of Rt 107. ] **Escort!**
11. turn right onto McDonald Dr, go 100 yrds, cross Rt 67 [NOTE: no sign for McDonald Dr after crossing Rt 67]
12. continue 0.9 mi. on McDonald Dr, which becomes Antlers Rd after crossing Sand Pit Rd; stop for lunch  
[ interval 8. - 12. distance = approx. 8.4 miles time = approx. 2 hr 48 mins ]
13. turn right exiting lunch field onto Antlers Rd, go 1.1 mi., to Rt 5 – Antlers Rd becomes Mohawk Rd across Rt 5
14. cross Rt 5, straight onto Mohawk Rd, go 1.1 mi.
15. turn left onto Main St, go 0.3 mi., cross Mohawk River using Lock 12 Bridge – 0.1 mi.  
[ Safeties, do not halt column ! ] Police assistance customary.
16. continue straight 100 yrds on Main St
17. stay straight onto Quakenbush St, go 0.2 mi. (approx. 500 ft)
18. turn left onto W Church St, go 0.1 mi. (approx. 300 ft)
19. turn right onto Main St, go 0.2 mi. (approx. 500 ft)
20. stay straight onto Schoharie St, go 0.4 mi. [NOTE: Schoharie St becomes Railroad St after left dog-leg.]
21. turn right onto Main St, go 100 ft
22. turn right onto Canalway Trail, go 0.2 mi., cross Rt 5S to stay on Canalway Trail (to be able to cross Schoharie Creek using the tressle – NOT the bridge for Rt 5S) **Police escort!**
23. stay on Canalway Trail, go 0.3 mi., crossing Schoharie Creek, and cross Rt 5S again to stay on Trail
24. continue on Canalway Trail, go 0.5 mi., passing under I-90 [ interval 13. - 24. 4.6 miles approx. 1 hr 32 mins ]
25. turn to the left to exit Canalway Trail at open area approx. 300 ft beyond I-90 overpass, directly parallel to Rt 5S, with open access to 5S; prepare to cross Rt 5S **in echelon** [ interval 22. - 25. [sic] 1 mi. = 20 mins ]
26. cross Rt 5S **in echelon**, and turn right onto Rt 5S, go 0.3 mi. to Shrine Rd **Police escort!**
27. turn soft left onto Shrine Rd, go 0.1 mi. to top of hill, each brigade reforms, pausing to venerate sacred ground [ interval 25. - 27. distance = 0.5 mi. time = 10 mins ]

**NOTE:** Each brigade reforms at top of hill, on the lawns in sight of the Coliseum church. Pilgrims venerate sacred ground there, a first time, ever so briefly, according to custom.

In thanksgiving for 29 years of pilgrimage, the column in 2024 processes again directly – on a bee line – across campus to the Ravine (singing e.g., the *Non nobis* as customary), to venerate the burial site of St. René Goupil – observing silence there, in order to recollect one’s pilgrimage intention/s and to form or/and to make firm one’s concluding resolution, and to pray for the grace to observe it faithfully for life.

Ascending the Ravine in continued silence & recollection, the column processes – singing resumed once emerging – toward the Coliseum, traversing the campus-green *directly, in a bee line*, to the site of martyrdom of Martyrs of *New France*. There, pilgrims venerate the sacred ground a *third* time, BRIEFLY but devoutly. Brigades reform at door, enter Coliseum one-by-one, **at the Chief of Brigadier’s word**, continuing in song. *Deo gratias!*
